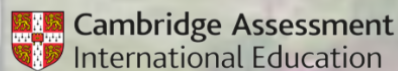

CONFERENCE POLICY

By registering for Mussoorie International School Model United Nations 2022, each participant is to abide all the terms and conditions set by the MISMUN team. Any delegate or faculty member violation the law would not be accepted.

ELIGIBILITY

- All participants for this conference must be currently enrolled in High School, i.e. Grade 9 (Class of 2026) to Grade 12 (Class of 2023)
- Teachers and administration staff must be 23 years or above to serve as the faculty advisor.
- MISMUN accepts individual delegates but they must be accompanied by faculty advisors.
- Schools Delegation must consist of minimum 7 delegates and maximum 14 delegates accompanied by 2 faculty advisors.
- Delegates registering against terms and conditions will be regarded as incapable to participate in the MISMUN conference.
- Those registered participants unable to attend conference because of missing a airline or any illness will not be given refunds or other considerations.

CONDUCT- DRESS CODE

- All the delegates must dress in western attire .
- National or traditional attire is permitted on the second day of conference i.e. 24th August 2022 where they may dress according to the country they are representing.
- If the attire is deemed inappropriately by the MISMUN team, the delegates would be not allowed to attend sessions till they change into the attire permitted by the conference.
- Clothing that is exposing must be avoided.

CONDUCT- OFFLINE CONFERENCE AND ETIQUETTE

- All the delegates are expected to maintain discipline during the span of conference.
- If any delegate will be held accountable for any disruptive behaviour during the committee sessions. Will be expelled from the conference without any refund at the discretion of the secretariat.
- At the stay at school if any delegate or faculty advisors found with alcoholic substances will not only be expelled from MISMUN'22 but from further participation in the conference.



- All the faculty advisors are responsible for safety, discipline and conduct of their students.
- Faculty advisors can observe their students and conference from back of the committee rooms.
- MISMUN is inclusive to all people regardless of race, colour, religion (creed), gender, country, or disability.
- Any delegate found discriminating any member present in the conference on these basis will be directly expelled from the conference. MIS as a community does not tolerate any type of discrimination.

EXPULSION FROM THE CONFERENCE

- The Secretariat retains the right to expel any Delegate, delegation, school, or group of Delegates from the conference at any time for breaking or failing to comply with conference regulations, or for any other cause.
- Any kind of harassment, including but not limited to verbal abuse, threats, online bullying, or maltreatment of fellow participants, visitors, or committee members, is prohibited at MISMUN.

FEE AND PAYMENT

Following fee structure applies to all delegates registering for MISMUN'22

- SCHOOL DELEGATION- 3000 INR per delegate
- INDIVIDUAL DELEGATION- 3500 INR Per delegate

- Schools that have not paid their fees won't be allowed to enter the school before the clearance however the allocation is also not guaranteed for the schools who have not paid the amount.

The fees shall include following:

- Lunch and dinner for all delegates and faculty advisors at school.
- Access to online interactive and training sessions with the chairs prior to the conference the details for same will be shared with the faculty advisors of the schools.
- Transportation fees and hotel charges will not be included in the amount.



ACCOMMODATION

- Accommodation shall not be provided to you at the school. The charges to which will not be included in the delegation fee.

TRANSPORTATION

- MIS may help arrange transportation from airport and hotels to those staying in Mussoorie but this includes separate transportation fee.
- MISMUN is not liable for any delays or missed flights.
- Schools to inform via mail regarding utilising the school transportation for arrival at school, latest by 25th July.

ELECTRONICS

- All the delegates may carry laptops along for the committee sessions.
- Participants may bring mobile phones along but are to submit them to their faculty advisors before the conference.
- All faculty advisors are to mute their cellphones during the committee sessions.
- MISMUN will not be responsible for the security of electronic devices.
- Delegates will not be allowed to use internet during the committee sessions however, they may save their information prior.
- If delegates found using internet will be expelled from the committee.
- Delegates chosen for the midnight crisis will be provided with the internet in school for research purposes two hours prior to committee proceedings.

COVID 19 PROTOCOLS

- No participant or faculty advisor will be allowed to enter or participate in the conference without a negative RTPCR test taken not more than 48 hours prior to the conference.
- All the faculty advisors and participants are to send a proof of their full vaccination to school by 25 July via e-mail.



Payments to the school are to be made by 22 July, 2022.
